


CoC March 2023 Data Reports






CoC March Data Reports

Call to Order: – Tonya Polidoro COC Chair called the meeting to order. 10:05

Welcome: Tonya Polidoro - Governing Council Chair

Tonya welcomed the COC and was excited to see the new partners at the meeting today.

Partner Spotlight: Allie Cohn - Ridgeview Behavioral Health

Regional Housing Facilitator out of Ridgeview. Ridgeview is in the process of getting their Mobile Health Unit, a large mobile fully decked RV to serve 5 counties. Medical and Mental health with a dual health provider, peer coordinators and an Office Manager. They will not dispense medicines but can write prescriptions for local pharmacies to fill. They will do intakes and you do not have to have insurance. They will be served that day. They will do acute care and minor medical procedures. They can do school and sports physicals. Anybody can come and get served.

New Business: Tonya Polidoro - Governing Council Chair

COC Successes: Many new agencies joining the COC.

Individual Agency News/Updates:

TORCH: Andy O Quinn - Opened the doors for their new shelter and have 9 families sheltered now. They serve literally homeless people in Anderson County. They have a "no child sleeps outside" policy. They have formed a lot of relationships with sober living and halfway houses to help combat that need in the homeless population. Partnership with the housing authority in Oak

Ridge they manage the shelter. Getting resources for the addiction side as well. They also offer RRH

Grants Awarded:

TORCH: Andy O Quinn - HOME ARP GRANT FOR SERVICES - RRH and Street Outreach

Clinch Powell: Sabrina Seamon - *EVICTION PREVENTION PROGRAM MONEY* - 50% AMI. Struggling with landlords willing to accept money.

Tonya: Is anyone in our COC that is SOAR certified: Andy said he used to be. MATS has a lady that needs SOAR assistance. Andy said that PATH in Knoxville used to have one. They only help those in Knox County according to - Sasha will double check. SOAR is a very extensive process.

Tonya: MATS was serving 3 counties that belonged to the ARCH COC. MATS is able to shelter them but not able to do RRH because services could be duplicated. MATS stopped doing RRH for those three counties. ARCH contacted Tonya and told her that they were not using RRH money but for SOAR. Jodie from THDA was aware of this so maybe this is a source.

Nikki - would it be beneficial if we established a temporary committee to look into SOAR for the COC. Tonya said it wouldn't hurt. Andy said there would definitely need to be a strong connection with someone at the SS offices.

TVCH COC: Katelyn McGuire - funding came out and we received the COC project funding this year. Katelyn is still looking at the process to see who qualifies and will get that out to the COC in the next coming months.

Nikki: TN Valley has moved to the habitat office but most are working from home. If you need anything email us or call us.

Shannon Dow: Blount CO there has been a group of volunteers, mostly non-profits have come together for several years now for homelessness and we have an upcoming listening meeting with the government officials to talk about affordable housing/low income housing and homelessness.

HUD COMMUNITY WORKSHOPS: Nikki Lynn

HUD is offering community workshops that last from April to August- once a week and they are very valuable. The COC has signed up for

COC Data Reports and Updates - Nikki Lynn

Data for MARCH: Tonya gave Nikki a report that was done in 2018 and if there is a report that someone wanted to see a certain way let me know.

Coordinated Entry Participation - 101 CES PARTICIPATION for MARCH 2023 The 2 previous years were different. Nikki mimicked the exact query for 2018 and it is very different. Tonya suggested that maybe COVID played a factor. Nikki suggested maybe it was because people know when our funding is and that is why people call in during certain times, they know we have new money. Nikki will continue to look at the parameters and see what can be reshaped to make the report more accurate.

COC CES by County - HAMBLEN and ANDERSON are the highest counties then BLOUNT. *The other counties do not have a lot of partnerships and we need to get more partners in those counties to get more accurate data.*

Data Quality POINT: we need to address these areas:

PRIOR LIVING SITUATION we need to collect as much data as possible.

UPON EXIT - PLACES NOT MEANT FOR HABITATION we need to make sure we are collecting that data as accurately as possible.

Data quality for the COC looked good.

HMIS HUD ANNOUNCEMENTS: Nikki and Katelyn listened in to the National homeless conference meeting HUD sponsored webcast meeting they announced they are changing a few more data standard points than Nikki initially thought. They are looking at changing race, gender identity, and changing the data standard of the SS number and will accept the last 4 of the social. That is going to help data quality tremendously. This is still tentative and official papers have not been released that will come in the late summer and will be effective in October.

Committee Updates - Nikki Lynn

HMIS & Data Management - Nikki Lynn

We have decided to look through the paperwork process and establish standards and procedures into data entry entering - exit - so that everything is standard across the board. It will be as generic as possible so that it conforms to all programs.
