


2022 Entry/Exits per County



Total number of Entries and/or Exits from programs in 2022:



2022 Services by Type





Call to Order: – Tonya Polidoro COC Chair called the meeting to order. 10:10

New Business:

Tonya Polidoro welcomed the agencies to the meeting.

Hoping to get back to in person meetings. Tonya asked the COC is that was something they would like to do?

Tonya talked about getting some resource people to come and speak at the meetings.

Tonya asked Katelyn if she could spear head that and set up a location and do a survey monkey to find out from others if they are wanting to do that.

Katelyn said that she could do that. Maybe do an in person and a zoom.

Tiffany Higginbotham suggested doing in person once a quarter rather than once a month.

Tonya said yes we can think about that too and the duel meeting.

Higginbotham goes to a couple meetings that are duel and it is hard to get comments in and be seen.

Nikki agreed that quarterly would be good for in person.

Nikki Lynn: Introduction of New COC members:

Live Free Claiborne: They deal with harm reduction and homelessness. Looking at people that need that kind of care going back and forth between treatments and individuals that have recently been incarcerated.

COC Data Reports – Nikki Lynn

Nikki stated that she knows some of the reporting last month was off, but she has things cleared up now.

Nikki showed entry's and exits per county and per agency.

Nikki asked that the COC let her know which format is more accessible for everyone.

Anderson Co having TORCH there has a lot of entries and exits because of their street outreach.

Nikki feels like these reports are much more accurate.

For the calendar year 2022 the COC had 3,763 entry and exits.

Nikki shared a report to show what kind of services the COC provided.

Jan Cagle asked who was racking Criminal justice and Legal Services and Nikki said she would go back and check that.

Data Quality didn't change we are still at a B. B is still good but we are looking for a 95 or above.

There are some things we can make sure we are doing.

Disabling Condition: If you check yes under that but you don't list anything it will generate an error. So if you check mark yes they have a disabling condition then we must list what that is.

Relationship to Head of Household: If you are entering a family make sure that you are going through and stating the relationship to the head of household.

Veteran Status: This is another very important box. Please make sure you are including this. This is important for funding as well.

Social Security Number: This one is very important as well. This number also has those included that would provide a number so the score is lower on it because of that.

These are the point that would ensure our quality score would go up. Try to get as much information as you possibly can.

Coordinated Entry will be separate form these data reports.

Jan-Feb 2023 Reports:

We have some counties that numbers are very low for. If you know of agencies we can partner with to provide these services please let us know so we can reach out to them. We know we have people there who need the help we just don't know the agencies to refer them to.

If you have questions about how to report in HMIS or need a refresher training please reach out to Nikki.

Nikki is working on the annual training that all HMIS agencies need to go through. We really need more agencies using HMIS so we can provide that full continuum of care.

PIT 2023: Nikki Lynn

We are still entering data and validating it. Final update will come out next month. Total number of PIT -554 Interviews/Surveys -502 Observations -52

These are not final numbers, we are expecting them to go up.

Nikki's goal is to show the COC a map once all data is collect4ed of the hot spots of where the homeless was counted.

COC Agency News: Katelyn McGuire – TVCH Executive Director

- TVCH is restructuring.
- Focus Center in Campbell County has been closed due to a loss in funding. We will continue outreach in Campbell County and we will partner is agencies in that area to fill in the gap.
- TVCH is moving offices. We will have desks and office supplies for sale.
- We have 6 staff members and chugging along.
- Help line accepted hotline calls and someone is dedicated to answering those calls now.
