Call to Order: Tonya Polidoro COC Chair called the meeting to order 10:12 a.m.

Welcome: Tonya Polidoro – Governing Council Chair

Tonya welcomed everyone and was excited to see everyone in person after three or four years.

Partner Spotlight: Andy O'Quinn – Executive Director TORCH

Andy spoke on lessons learned, things that worked for TORCH and how they were able to build up in Anderson County from a tiny agency to an agency with multiple services, multiple case managers and having a few non congregate shelter properties.

You need community acceptance. Talk to city officials – help them understand what your agency does, be partners.

Next, you need to stay focused. Look at your past statistics and see how you can help the most people (where do you get the most bang for your buck?). By staying focused TORCH has figured out different paths out of homelessness. Example: I'm homeless because I lost my job. TORCH has a path. I'm homeless because my income cannot pay for childcare and a home. TORCH has a path. I'm homeless because I have an addiction. TORCH has a path out of homelessness for you.

Remember – keep the door open for people to fail. When this happens, let it go, move on. You will never understand why.

How could the CoC be useful? Ask your partners about the different grants they are on. Ask about forms you might use when housing people. Ask about their policies and procedures. You do not have to start from scratch. Andy and Katelyn spoke about a public shared drive for generalized information.

Andy encourages you to reach out to him for anything or any advice.

New Business: Tonya Polidoro – Governing Council Chair

Individual Agency News/Updates:

TVCH Katelyn McGuire: We have open spaces for our Permanent Supportive Housing Program. We have six open spaces in our Veteran Focus Program and two open spaces in our Family Services Program. There are certain eligibility requirements. If you know of anyone interested, feel free to contact us. If you have any clients that might benefit from these services, feel free to refer them to us. The requirements are: Chronic homelessness, a documented disability, and someone who can vouch for the chronically homelessness.

We have more donations than our storage facility can handle. If you have any certain needs or any certain things that your organization needs, please let us know. We will make a list and let you know when we have it. We have lots of men's and women's clothing.

Our open spots are in all 12 counties of our CoC.

Legal Aid Society-Paula Murphy Trujillo: The Legal Aid Society will have a clinic on the third Tuesday of this month. This is for bankruptcy, probate, and estate matters. 1-800-238-1443. ptrujillo@las.org

Unknown Speaker: There is a job opening in Campbell County for a social worker. It will be on USA jobs until May 22, 2023. It's a therapy mental health job.

Volunteers of America: Volunteers of America has an outreach position open.

CoC Data Report: Nikki Lynn – Director of Date Management TVCH:

PIT/HIC 2023 from January 25, 2023. A total of 170 sheltered, 514 unsheltered, and a total of 684.Now we are going to talk about what it looks like to gather PIT data. We rely on community partners to help in all 12 counties for the PIT data. We need everyone's help, everyone to be on the same page when we are recording and filling out the same paperwork the same way. Next year everyone should be using 2024 paperwork.

From the 10-year trends, it is going down, but there are dips. Last dip was 2020 during covid. It is going back up since we are coming out of Covid.

This number is not going to be accurate. Not all data could be counted because of HUD's definition. They have to be literally street homeless (on the street or vehicle; without power) and we are an emergency shelter. We cannot count Rapid Rehousing nor PSH.

PIT/HIC 2023: Anderson 174, Blount 175, Campbell 80, Claiborne 7, Cocke 42, Grainger 0, Hamblen 88, Jefferson 22, Loudon 15, Monroe 4, Sevier 4, Union 14. Monroe, Loudon, and Jefferson were lower because we did not have partners there to do the search. Also remember it was January, very cold and hopefully the people had somewhere warm to stay.

Something I found interesting: We actually had people that identified as not female or male. We had single gender or transgender folks report which is awesome. About 445 people identified as white and only 40 (the next highest) was African American. People who self-identified with mental health disorders were 236. We had over 250 that identified as having drug use.

If you use the counting us app, it will drop a pin where you are. Also – lots of churches will pay for hotel rooms for the homeless. That is why we need to build partnerships so that we can get those numbers. This data is reported to HUD, they compile it all and take is to Congress.

Knox County had 1,200 folks. So out of 12 counties, we do have more homeless individuals.

Macrea Love TVCH:

We did find 14 individuals on the street, but I don't feel that number represents the problem in that community (Union County). There are entire communities without water, without electricity. I've found more encampments. There are people living in tents next to the shoreline at Norris Lake and people living in broken down houseboats.

Also Monroe County: People gathering together, sharing motel rooms, and living in RVs. I think it is very important when we do the PIT in the future to know the area that we are covering to identify these at risk communities.

Unknown Speaker: Does the CoC conduct any telephone surveys? Example of what we do: We run a report in HMIS to see the people that we have identified that were homeless through street outreach in the last three months. We call them and if they are still homeless, we include them in the PIT.

Unknown Speaker: Since we need more volunteers it would be a good idea to tap into some of the colleges and universities.

Letisicia McQueen West Care: We would like to help with the PIT.

CoC Updates:

Katelyn McGuire TVCH

With the CoC, there are funding opportunities that come from HUD. The CoC is like an umbrella in that it is able to disperse funding into our communities. They are anticipating that the NOFO (Notice of Funding Opportunities) is to be dropped in May or June. Application Process will involve the rank and review of submitted programs. Once information on the application is released, it will be available on the TVCH website for CoC Members. I want to

Allie Cohn Creating Homes Initiative – Ridgeview

There is a statewide conference being held in Chattanooga. It's called Leading The Way Home. It is being organized by the Chattanooga CoC. The overview is that it's a best practice to address homelessness. There should be something for everyone and a great way to network with other partners from across the state. They are offering student discounts; you can use HUD funding grants to attend and there is a 50% off of registration for volunteers. Even if you can only go for a day, it would be worth your while. They will have national presenters from HUD and from the National Alliance to End Homelelsssness.

THDA is going to be coming out with some additional guidance later in the year – but we want to go ahead and update what we have and what's required right now. Rank & Review Committee – Allie Cohn <u>cohnab@ridgeview.com</u> if interested. When the NOFO drops there is a process and included in that process is a rank and review of submitted proposals for funding. We need to put a committee together for our CoC to review those proposals. We want to make sure that projects that are submitted are appropriately ranked and fairly ranked and submitted to HUD. We need committee members to join soon because the NOFO is going to drop. We need to get the timeline together, make sure we have our threshold requirement documents together, and make sure we have a ranking tool that feels comfortable. On this committee we are responsible for reviewing all the applications and we want to make sure that they meet the eligibility and threshold requirements. We would need to meet as soon as the NOFO drops. Once every week or two weeks for an hour or less. Then when ranking and review would happen once all the proposal have been submitted. That is usually a four hour process that happens in the morning and it's close to the end of when the application would be submitted. Please email if interested in joining this committee.

2023 CoC Member Dues: Tonya Polidoro

Karen got the 2023 membership invoices out with a due date of December. We want to bump that to 60 days because having dues paid drives the voting rights that you have as part of the CoC. If new members join after September, their dues will pay for the next year.

Katelyn McGuire TVCH: I wanted to mention is TVCH manages the call line for Eastern Tennessee. I wanted to throw some numbers out there so everyone is aware of the kind of assistance needed. Last month we received over 600 phone calls through just the helpline. We receive at least 100 emails a month requesting help. These numbers are very concerning when you look at the PIT count. Once again, the number of people that we can physically count in an area does not represent all the needs that we are seeing in our helpline, case managers and website. People are in need in all our counties currently. With that being said, there are only so many direct services that TVCH itself can offer. We will do a referral to those organizations in that county that the individual is in. If you are not currently receiving any referrals from us, and would like to get on the resource list, please let us know so that we can get you added.

Bruce Spangler – Retired from Volunteer Ministry Center: I want to continue to be part of the solution, if I may. If I can help with your organization in terms of visioning, mission, strategies, or Grant Writing. I will leave my card with my contact information. 
