Call to Order: Katelyn McGuire – CoC Lead

Called the meeting to order 10:06 a.m.

Welcome: Katelyn McGuire – CoC Lead

Good morning, everyone, thanks for coming. We have been having technical difficulties this morning.

Partner Spotlight: Melina Politte – Haven House Domestic Violence Services Executive Director

We are located in Blount County. We serve all surrounding counties and every state. We have clients that come in from all over.

We are a domestic violence program. We have a shelter aspect to our program, but we also do a lot of outreach. We have a hotline.

There are so many stages to leaving a domestic violence situation, and we try to encapsulate all of that, so that we are a wraparound service.

Domestic violence is an intentional behavior, and the purpose is to establish some kind of power and control over another human. It is a pattern of abusive behavior, threatening behaviors, and it may include physical, which we all know, but also emotional, economic, and sexual. What is happening is the abuser is seeking control of the thoughts, beliefs, and conduct of their intimate partner. They are using a wide range of tactics, from coercive to abusive behaviors, threatening, isolating, manipulation, humiliation, and even using their vulnerabilities against them.

A lot of the people we serve come in and everyone knows the physical side, but it is not just the physical side. A lot of people we serve have never been physically abused, but their life has been threatened. They have been manipulated; they have been isolated from their families. We have served people that have been in a marriage for over 40 years and have never seen the finances. Domestic Violence is not an isolated incident. It is a pattern of behaviors.

Haven House has been in existence for 41 years; we started in 1982. There was abuse going on in our community. The church got together along with our Chilhowee Club and said we need to do something about Domestic Violence. Before it was like the Underground Railroad. The churches would get somebody who was experiencing violence out and then move them along. Then the community came together and said we needed something. We have really grown within our community ever since.

Our mission is to save and change lives impacted by domestic violence through education, prevention, and intervention. Everything we do is filtered through our guiding principles, which are safety, accessibility, compassion, confidentiality, and integrity.

Services that we offer:

*24-hour hotline: You can always get one of our staff.

***Court Support:** We have a court advocate that goes to court. They help people file orders of protection, and then help them through that process.

***Shelter:** We have an 8 room shelter with 15 beds. We provide food, clothing, and basic needs for them and their children. We get their children enrolled in school. We work with our partner agencies to home our families because they are homeless (once they are moving from Haven House)

*Safety Planning: Making sure their phones are not tracking them.

*Counseling: Job & mental health counseling.

*Snap Benefits: We help people get signed up for snap benefits.

*Housing Applications: We help people fill out housing applications.

*Support Groups:

***Outreach Services:** We have an outreach office where people can come and receive domestic violence, counseling, and they can receive all the services that we provide in shelter but at an outreach capacity.

If you would like to get involved with domestic violence one on one training, training for your organization, participate in any of our events, or just want to come and understand what we do, we are open to any of those.

Tiffany Higgenbotham – VA:

Can you take men that have experienced domestic violence?

Melina Politte – Haven House

Yes. 15% of our clients are men. We do not house men in our shelter, but we house them in other ways. We provide men the same service.

Katelyn McGuire – TVCH

What is the referral process? Do we just call the phone number?

Melina Politte – Haven House

Yes, our hotline number. We will screen. We typically try to screen in versus screen out. We partner with other Domestic Violence Programs.

Do you require a referral if they are coming from out of state?

Melina Politte – Haven House

No, our referral process is really our hotline.

New Business: Katelyn McGuire – CoC Lead

Do we have any agency updates? Does anyone have any events coming up that we can use to support your agency? Any successes that you would like to talk about?

Individual Agency News/Updates:

Tiffany Higgenbotham – VA:

I wanted to introduce our new outreach workers: Montana Yates and Florence Sutton. I'm hopeful that they will be able to go along with you and to each of your counties as time progresses, to do some street outreach. They can also work with clients and come out and visit clients and encampments together or meet in your office.

We do still have our walk-in clinic that is at our office Monday through Friday from one to three.

Allie Cohn - Creating Homes Initiative – Ridgeview:

We have a mobile health unit that serves Campbell and Union County. Campbell County on Tuesdays 9-3. Union County Thursdays 9-3. We just hit our 100 service this month and it has only been out about a month. It is an integrated primary care, behavioral health care, and mobile health unit. There is no appointment necessary. Services are free. This mobile unit goes to Morgan, Scott, and Fentress County. Go to the Ridgeview Website for counties and times.

Jan Cagle – Ridgeview:

We are having our Oak Ridge Fall Classic 5K. It is September 16, 8:30 in the morning. It's a run, walk. We have done it annually for quite a while now. It will be at Melton Hill Lake Park. There is information on our website, and I can also send information to the Coalition.

Katelyn McGuire – TVCH

We were able to get it approved through our funding to open one of our permanent supportive housing programs, and we are able to offer housing to both veterans and non-veterans out of that program now. We have some available spots. If you know anyone who might be eligible for those spots, eligibility requirements, kind of surface level, are chronically homeless and living with a disability. If you know anyone who might be eligible or you want to chat about the possibility of eligibility, feel free to refer to us, and we can do the prescreening information and the prescreening session to see if they are available. If so, we can work on getting them into housing.

Question:

Do they have to have income?

Katelyn McGuire – TVCH

They do not have to have income. There are calculations set out by HUD if they do have income. But other than that, income is not a requirement.

Cherokee Health Matt Magrans-Tillery:

We have a new psych provider coming on board with us at the Maynardville Office. She will be stationed on site, but she will be able to see psychiatry for several different sites. If you have anybody that needs a new psych appointment, or even just getting in, we have availability there. We are also at our Maynardville and Washburn site in Union County and Grainger County taking on new medical patients. Tenn Care has changed quite a bit with their guidelines at post covid protocols, we know people are really trying to get in. If they are having difficulty getting in, please have them call our a centralize access number 1-866-231-4477 #711.

Florence Sutton – VA:

Melina Politte, does Haven House work with other Agencies out of State?

Melina Politte – Haven House

Yes, often.

Also, we are hiring advocate positions within our SafeHouse. Our positions are on Indeed if they know anyone who is wanting to get into our field.

Albrianna Jenkins – Community Member:

\$10,000 grant opportunity due August 2023. Must be submitted by a Gilman Alumni and if funds are received, they can be passed along to a nonprofit. My proposal includes closing the digital divide and allowing resources to reach those who need it most by hosting a Gilman-organized device drive to collect unused mobile devices/technology that would otherwise end up in landfills. [Community partner] would redistribute unused technology with a pre-paid plan for up to xx months including contract to community resources (Uber, Non-profits). CoC Data Report: Nikki Lynn – Director of Date Management TVCH:

This is what is going on with our data reporting. B. We are still out of beat, which is not acceptable at HUD standard.

Top 3 Monthly Data Quality Errors:

- 1. Length of Previous Stay
 - This is important because it helps determine chronic homelessness.
- Relationship to Head of Household This is where the kids come in. We cannot determine if you are head of household if you are not entering families correctly. This is included on their individual assessments.
- 3. HUD Verification Tables They are the tables that you see that have a big green checkmark in the right corner. They want to know income, disability type and health insurance. If there is income for the child, it is important to include it. It is important to mark yes, they have income. Yes, they have no cash benefits. Yes, they have income from disability, but it is required for head of household.

2023 NOFO Timeline

*August 1, 2023 – Any agency interested in applying for CoC Bonus funding or Domestic Violence Bonus funding must provide a written request to the Collaborative Applicant Lead detailing intent to apply. Collaborative Applicant Lead – Tennessee Valley Coalition for the Homeless Executive Director, Katelyn McGuire | kmcguire@tvceh.org | 812-453-0354.

*August 25, 2023 – Agency applications due in e-snaps.

***TBD – Rank and Review Committee** will convene to review individual agency applications and create a priority list of all accepted applications.

*On or before September 15, 2023 – Any applicants not selected to be included in the collaboration Application package will be notified in writing.

*On or before September 24, 2023 – A draft of the CoC Collaborative Application will be publicly posted for CoC review at <u>https://tvchomeless.org/cocnofo2023</u>

***September 26, 2023** – TVCoC intends to submit the final and approved Collaborative Application in esnaps. The target date is before the official HUD CoC Program NOFO deadline of September 28, 2023

Anticipated funding available: \$139,892

Applicants can seek funding for new, eligible programs. The amount available for the CoC Bonus is dependent on various factors including TVCOC's overall application score, the new project application local rank as determined by the TVCoC Rank and Review Committee, and quality of the project application. Eligible categories for CoC Bonus funding are summarized below:

*PH-PSH projects

*PH-RRH projects

*Joint TH/PH-RRH component projects

*Dedicated HMIS project for the costs at 24 CFR 578.37(a)(4) that may only be carried out by the HMIS Lead, which is the recipient or subrecipient of an HMIS grant and is listed on the HMIS Lead form in the CoC Applicant Profile in e-snaps. Additionally, if the CoC has organizations within its geographic area that are victim service providers, the HMIS Lead, or subrecipient, may request HMIS funds for a comparable database. Victim service providers may also request HMIS funds in their project application budgets to enter data into a comparable database.

*SSO-CE project to develop or operate a centralized or coordinated assessment system.

Anticipated funding available: \$199,846

Funding is available for projects specifically creating new programs to address the needs of victims and families of those who have experienced domestic violence. CoC Domestic Violence Bonus funding is a nation-wide, competitive opportunity dependent on various factors including TVCOC's overall application score, the new project application local rank as determined by the TVCOC Rank and Review Committee, and quality of the project application. *SSO-CE project to implement policies, procedures, and practices that equip the CoC's coordinated entry to better meet the needs of survivors of domestic violence, dating violence, sexual assault, or stalking.
