Started in 2002 First home completed in 2004 Over 100 homes completed since

We are a very small but mighty nonprofit headquartered in Maryville TN. We provide affordable housing solutions for your typical home ownership style home program. We were an offshoot from Blount County Habitat. At that time Habitat was serving the 60% below AMI. FCDC serves those in the 60 to 80% range.

From 2002 until about 2018 Kelly Spears and Bill May were the backbone of the organization. They both retired in 2018. From 2018 until last year, the organization kind of sputtered without them with little leadership. I was working at Habitat and we decided we needed to get this program back up and running. We had our first board meeting October of this year.

The Situation



Shortage of affordable housing

Homeownership Program

- Qualifies eligible applicants for low-interest USDA mortgage
- Mortgage can be used to purchase FCDC built/rehabbed homes OR buy on the open market.
 - Why would you want to buy open market vs. FCDC built/rehabbed?
 - · Building capacity
 - · Household size





Must be low-income

Determined by annual USDA banded income limits* (60-80% AMI)

*This threshold changes depending on funding being used.

Must be able to afford the mortgage

Minimum 1st mortgage of \$205,000

Debt, Credit, and More

- · Existing debt affects applicant's ability to repay
- · Credit score must be 640 or higher
- Other requirements may be applicable depending on funding sources being used

Basic Criteria





New Construction

- Variety of available floor plans that buyers can choose
- 2 level, 1 level, ADA accessible, with or without garage
- · 3 bed, 2 bath minimum currently
- 1200-1400 sq. ft. living space




Rehabilitation

- Neighborhood revitalization
- Typically lower 1st mortgage requirements
- Faster turnaround

So, in addition to our home ownership program, we are looking at launching a rental program. We have got our special exception secured to develop a duplex that you can see below. We will make it affordable for Section 8 rental limits. We are going to partner with the housing authority.

Rental Program

- · Targeting 50% AMI and below
- · Section 8 voucher based
- · 1st units are planned for development (duplex)
- · Pending funding application




CoC Data Report: Nikki Lynn – Director of Date Management TVCH:



In October we had 101 Coordinated Entries come in.

You can see the trends from the last two years have gone up. It may be that we are shifting. We will see in the next few months. It may be that with folks being in rentals already, and their rent becomes unaffordable, we could not do a coordinated entry to place them into some kind of housing program.

We have across the CoC, 388 active participants. This is street outreach, PSH, and emergency shelters. You can see that outside our area which MATS covers a few counties we have 15. Hamblen has 16. You can see Blount County has the second highest and that is because we have information coming in from Helen Ross McNabb in their street outreach. Anderson County has the most, they have a very active street outreach program as well as their transitional housing with their no child outside policy.



I have pulled out white on this graph because white is the predominant race in our area. You can see that in the month of October the folks that we serve are 74.84% were white. I have compared the numbers between the census information that is used by HUD to compare racial disparities with our point in time count information. You can see Black or African American in the month of October was much higher than the actual percentage in the census from across population. You can see that as well as multiracial are predominantly more affected and seen more in housing services than in the normal population. That is something we need to think about and consider when we are making policies, when we are thinking of programming across our CoC, is that we definitely see a larger increase of those racial populations in our communities for whatever reasons. That is why the new data standard has combined race and ethnicity.

feedback. We understand that in our communities there are biases, there are prejudices, and
there are your unconscious thoughts and preconceptions of folks that experienced
homelessness. So before we are able to create the type of education and materials that we
need for our communities, we need to understand people's thoughts, opinions, and
preconditioned notions of those experiencing homelessness. We are currently working on a
plan to come up with some sort of basic type of survey that we are going to pilot in one
community to try and see how to best interact with the community, how to get input, and then
once we get that feedback, we are going to send it out CoC wide. We understand each county,
and possibly even the city within the county will have their own things that that they need to
address. We are hoping within a year we have those types of materials that we can put out to
the CoC and folks can use them for awareness and advocacy. If your are interested in
