

#### What is the AHAR?

The Annual Homeless Assessment Report (AHAR) is a HUD report to the U.S. Congress that provides nationwide estimates of homelessness, including information about the demographic characteristics of homeless persons, service use patterns, and the capacity to house homeless persons.

Without correct numbers and without correct data quality in HMIS, it will not mean anything to Congress. Therefore, we will not get the funding that is required to help solve the issues that we are experiencing in our homes and communities to help the individuals that we serve every day.

#### What is LSA?

The Longitudinal Systems Analysis (LSA) report, is produced from a CoC's Homelessness Management Information System (HMIS) and submitted annually to HUD. HUD has a third party consulting group that goes through with a fine tooth comb looking for items that does not match. Then they kick all the data back to us with any errors. This is why you may get emails from us. This report helps determine funding from HUD.

Both LSA and System Performance Measures (SPM) are very important but different. LSA focuses a lot more on households. SPM focuses more on individuals. Both are data that come from HMIS.

#### What is PIT?

The Point in Time (PIT) count is a count of sheltered and unsheltered people experiencing homelessness on a single night in January. Each count is planned, coordinated, and carried out locally. It is done the last 10 nights of January every year. HUD requires that CoC's conduct an annual count of people experiencing homelessness who are: unsheltered or sheltered.

The unsheltered count is an enumeration and demographic survey of unsheltered individuals and families on the streets, in tents, in vehicles, and sleeping in other locations not intended for sleeping.

The sheltered count is an enumeration and demographic survey of individuals and families in emergency shelters, domestic violence shelters, transitional housing programs, hotels/motels paid for through community resources.

We are doing this for just one night in January. And yes, it is cold-hopefully they are in shelters. But we are only telling Congress about one night? This is why the LSA is included. Your data and your data quality and tracking in HMIS throughout the year is just as important as the PIT. They go together.

#### What is the HIC?

The Housing Inventory Count (HIC) is a point in time inventory of provider programs within a Continuum of Care that provide beds and units dedicated to serve people experiencing homelessness (and, for permanent housing projects, where homeless at entry, per the HUD homeless definition)

The HIC is categorized by five Program Types:

- 1. Emergency Shetler
- 2. Transitional Housing
- 3. Safe Haven
- 4. Rapid Re-Housing
- 5. Permanent Supportive Housing

#### Individual Agency News/Updates/Agency Successes:

#### Katelyn McGuire | TVCH

TVCH will be initiating our shower trailer program in 2024. Our shower trailer is in production but should be going live in the next couple of months. If you as an agency or anyone you might know would be interested in hosting a shower trailer, please reach out to us.

We were recently awarded a grant through the Federal Homeland Bank for development of a duplex which we are going to use for our first rental. Maybe in the first quarter of this year we will be breaking ground and maybe by the end of the year we will have it completed.

#### Sage Pearson | YWCA

I work for the YWCA as the LGBTQ Victim advocate. I will be serving on this panel as the YWCA Representative partially and mainly because I am looking to open an emergency shelter for the LGBTQ community in our area. I am looking for advice and any guidance anyone on this committee may have on how to work through the process of getting everything set up since this is a first for me. I have a plan written up, and if anyone would like to help me tweak it, modify it, shape it, I would be greatly appreciative of that. Thank You

#### Rev. Jon Faraone | Shelter My Sheep - HMMC

I am with Center Presbyterian Church Tellico Plains, Monroe County. We represent Monroe County. I am the chair of the Homeless Management Monroe County. Barbara Raper was heavily involved here. She has since passed away and I have taken that baton, and running with it now with my sidekick, Emilie Carroll. Emilie is also a member of Center Presbyterian Church, and a part of Shelter My Sheep Ministry which started at our church. We have four micro houses that we built. Two in Sweetwater and two in Tellico Plains. This is transitional housing. Temporary, families or individuals stay there a month for free. If they do not have a job, we give them a job. Our goal is to help them get back on their feet. We have been blessed with success stories, but we have also had challenges as well. Homeless Management Monroe County is the umbrella organization that was started by Barbara, myself, and Boyd McClure,

which Boyd has since passed away. We want to get more involved and reconnect with the TVCoC. We are facing housing shortage and homeless population growth.

Sharon Davis at Lighthouse Ministry of True Purpose has converted an old motel. Half of it is operational right now because of a code issue with the steps. We are going to try to co-op together and get a grant to establish a homeless, transitional situation in Madisonville. She was able to pick up a try wide, the old Chota Medical center, that we are going to convert to temporary housing for the homeless.

Mike Dodson at Fresh Start has a shower bus that he converted and drives around in the summer, but that is Monroe County. If you have any questions for us or Emilie, just let me know.

That is where the funding comes in through Federal resources. Members of the CoC apply to the pot of funding that is funneled down through Tennessee Valley as the collaborative applicant. 




Percentage of The Total Number of Active Programs for the

That is a very good question. We are in the process of revamping that and we will be noting it in our policies and procedures for coordinated entry because that is typically where we gather that information. We have recently updated our coordinated entry assessment, which is kind of like our intake to ask the following questions—Tiffany--

#### Tiffany Higgenbotham | VA

I don't have it in front of me, but it spells out that they have to have one day of active duty, unless they are a National Guardsman, and they had to be called up by Presidential order. It's on self-report for HMIS. They don't have to have their DE214. If they are homeless, I can help them get that in a lot of cases.

Christopher "Matty" Mathison | State of TN: Disabled Veteran Outreach Specialist What if someone has a dishonorable discharge, but with one day of active duty, is that acceptable?

#### Tiffany Higgenbotham | VA

As far as the VA Homeless services, they can have other than honorable, they can even have bad conduct discharge. But the two things they cannot have is dishonorable or a general court martial from bad conduct with general court martial. If they have a special court martial, they can. With the two categories that they cannot have, we refer them to the VSO to try and get a discharge upgrade.
