Partner Spotlight Community Coalition Against Human Trafficking (CCAHT) Hayley Griffith Education & Outreach Coordinator Hayley@ccaht.org https://growfreetn.org 865-770-8037 In the State of TN you have three different organizations that are commissioned by the Governor to provide counter trafficking services in all 95 counties in TN.



Anytime TBI does a human trafficking sting in one of these counties they will involve our organization so that we can provide aftercare services to those survivors. We also work very closely with DCS as well.

A lot of times when we think of trafficking, we think of human smuggling. We think of movement across the border. But human smuggling and human trafficking are statutorily very separate and distinct crimes.

Smuggling is a crime against a border. Trafficking is a crime against a person. A lot of people think trafficking happens through someone being kidnapped by a stranger, but we really see that.



Below are three different elements. You must have all three of them in order for there to be a trafficking victimization. For sex trafficking, you have a sexual act. You have that being an exchange for some type of money or commodity. Anything of commercial value is going to count. It can be food, shelter, drugs, anything that has commercial value. If a sexual act is being exchanged for that through the use of force and coercion, that is when you have trafficking. So, if you just have two of these elements, if you just have a sexual act in exchange for money, that would be considered prostitution, which is still a crime in the State of TN. If you have the other two elements, you had sex through force, that would be sexual assault or rape. It is when you have all three of them working together that you have a trafficking victimization.





The above is a low estimate as to what the scope of the problem actually is because human trafficking is such an unreported crime. Studies show only about 14 to 18% of cases get detected.

### FAMILIAL

- Family member acts as the trafficker
- Most common form of sex trafficking in rural communities
- Often multi-generational

 Crime of opportunity; recruitment of victims is convenience-based; may only be advertised by word-ofmouth

### INTIMATE PARTNER

- Someone outside the home/family
- Someone in a "relationship" with their victim
- Involves strategic, targeted exploitation of vulnerability(ies)

Familial is typically the biological mother who is acting the trafficker, so Mom is trafficking the child because she was trafficked by her mom. It goes back and back and back through that family line as a way to provide for basic needs. In our region, bio dad is the trafficker by a very small margin.

# VULNERABILITIES

Involvement with the child welfare or juvenile justice systems History of running away Homelessness Financial hardship/poverty LGBTQ+ identity Immigrant or refugee status History of physical or sexual abuse Self or familial substance use or mental health problems Unmet intangible needs (*e.g.*, love, affection, belonging, protection) Low self-esteem/lack of identity Lack of familial/relational/social supports

When we have individuals that are presenting a lot of different vulnerabilities, especially the more that are co-occurring at one time, the more we begin to wonder if there is some type of trafficking victimization going on.

When a minor is involved in sex trafficking, you do not have to prove force or coercion anymore because of age consent laws all you have to know and show is that the minor is exchanging a sexual act for something of commercial value.

For adults, two of the top vulnerabilities that we see are a history of physical or sexual abuse with a co-occurring substance use disorder problem. So anytime there is maybe sexual assault or substance use disorder co-occurring at the same time, it is a really good time to slow it down, have more of a thorough and assessment to see if there is some type of trafficking victimization going on.

# **REFERRAL PROCESS**

What does it look like when someone calls the hotline?

### Answering the Phone

- GFTN Staff will answer hotline and verify that potential client is safe and comfortable to talk.
- One of two options will take place if the potential client wants to continue with the conversation:
  - 1. If available, GFTN will send staff to meet in person with potential client.
  - 2. If unavailable, GFTN staff will continue with questionnaire over the phone.

### Qualify - Now What?

- Once determined they meet criteria for GFTN services, we give brief description of what services are available and let them make their decision and next steps.
- If client is interested in emergency shelter, we would then discuss release / transportation.
- If client is interested in community services (therapy, care coordination) we will have a direct staff member follow up as soon as possible.

It is a 24-7 hotline where an actual person will answer.

# THE ERC

Discharge from hospital, rehab facility, release from jail, etc.  $\rightarrow$  Appropriate for Emergency Receiving Center:



The ERC is temporary. Average stay is two weeks to 40 days.

Individuals who can stay at the ERC are over 18 and identify as female. If we have an individual who identify as male or they have a disability, they can't manage stairs, we will find an alternative option. A Hotel if we need to.

### **CoC Data Reports**





In May we had 156 coordinated entries. This is the intake process that you add into the HMIS database that a lot of our programs us across the CoC. Coordinated entry captures different information, demographics, living status, homelessness status, things like that. It is utilized to help prioritize folks into services and programming as well as it is used to determine what they might be eligible for programming wise. 156 is a lot higher than last year. A lot of that is the amazing work that all the organizations are doing within our counties. You have Anderson and Hamlin leading the way here. Also, at TVCH we have been able to bring on a dedicated coordinated entry person who is partnering with the outreach person as well.

For the past 4 years or so I have helped coordinate the rank and review committee for the Collaborative application. This year I am super grateful, **Angela Stope | Blount County United Way** is going to co-chair with me. We are responsible for helping to rank the submitted projects that go into the collaborative application in order to receive funding from HUD for permanent support of housing, supportive services, the planning grant, HMIS, and coordinated entry. All of that is what we rank and review. We are hoping to get new members on the committee this year. We would like to get people who are able to help with the ranking tools themselves. We develop those based off of the HUD guidline. We don't always know what needs to be ranked until the NOFO actually comes out from HUD. We also need people to serve as members for the actual rank and review session. Going through those applications and using those tools to rank and review projects in order to determine their prioritization.

### Rank & Review Committee



- Project applications submitted to the CoC for the FY 2024 application cycle must be reviewed and accepted/ ranked, approved, or rejected by the CoC.
- The Rank & Review Committee is looking for 3-5 individuals from community partners to help with the rank and review process for 2024 NOFO, which includes the following responsibilities:
  - Help develop and update TVCoC ranking tools
  - Participate in the review and ranking process
  - Help document scores during the ranking process
  - Submit ranking outcomes to TVCoC membership
- > Time Commitment

- Up to 1 hour/ week leading up to NOFO announcement (typically early to mid-July)

- 4-6 hours (broken into 2 days) to rank projects as a committee

- Time commitment will increase during the review week to accommodate the review of all project applications. This can vary depending on each committee member.
