LABOR TRAFFICKING

SEX TRAFFICKING

Work or provide services

The use of <u>force</u>, <u>fraud</u>, or <u>coercion</u> to make an individual...

Engage in a commercial sex act(s)

FAMILIAL

- Family member acts as the trafficker
- Most common form of sex trafficking in rural communities
- Often multi-generational
- Crime of opportunity;
 recruitment of victims is
 convenience-based; may only
 be advertised by word-of mouth

INTIMATE PARTNER

- Someone outside the home/family
- Someone in a "relationship" with their victim
- Involves strategic, targeted exploitation of vulnerability(ies)

VULNERABILITIES

Involvement with the child welfare or juvenile justice systems

History of running away

Homelessness

Financial hardship/poverty

LGBTQ+ identity

Immigrant or refugee status

History of physical or sexual abuse

Self or familial substance use or mental health problems

Unmet intangible needs (e.g., love, affection, belonging, protection)

Low self-esteem/lack of identity

Lack of familial/relational/social supports


CCAHT

REFERRAL PROCESS

What does it look like when someone calls the hotline?

Answering the Phone

- GFTN Staff will answer hotline and verify that potential client is safe and comfortable to talk.
- One of two options will take place if the potential client wants to continue with the conversation:
 - 1. If available, GFTN will send staff to meet in person with potential client.
 - 2. If unavailable, GFTN staff will continue with questionnaire over the phone.

Qualify – Now What?

- Once determined they meet criteria for GFTN services, we give brief description of what services are available and let them make their decision and next steps.
- If client is interested in emergency shelter, we would then discuss release / transportation.
- If client is interested in community services (therapy, care coordination) we will have a direct staff member follow up as soon as possible.

THE ERC

Discharge from hospital, rehab facility, release from jail, etc. > Appropriate for Emergency Receiving Center:

Cleared medically and mentally stable (with meds)

Ideally 30 days of prescribed medication

Follow up appointments set (specialists, PCP, med management)

Can manage stairs

Not in need of 24/7 care / supervision

Open to community living / shared space


If in active addiction, ability to not have drugs on property Knowledge that ERC is temporary and not a permanent solution

Ideal for actively fleeing individuals with recent history of trafficking

Over 18 and identifies as female







Rank & Review Committee



- Project applications submitted to the CoC for the FY 2024 application cycle must be reviewed and accepted/ ranked, approved, or rejected by the CoC.
- The Rank & Review Committee is looking for 3 -5 individuals from community partners to help with the rank and review process for 2024 NOFO, which includes the following responsibilities:
 - Help develop and update TVCoC ranking tools
 - Participate in the review and ranking process
 - Help document scores during the ranking process
 - Submit ranking outcomes to TVCoC membership
- Time Commitment
 - Up to 1 hour/ week leading up to NOFO announcement (typically early to mid July)
 - 4-6 hours (broken into 2 days) to rank projects as a committee
 - Time commitment will increase during the review week to accommodate the review of all project applications. This can vary depending on each committee member.
