### Call to Order: Tonya Polidoro – Governing Council Chair

Called the meeting to order 10:03 a.m. Tonya welcomed everyone for connecting for another month.

### **CoC Program Application: Katelyn McGuire – Lead Agency**

If you have been to previous meetings, you have heard me talk about the CoC Program Application. (also known as CoC NOFO and HUD Funding) Below are terms for reference.

# **HUD CoC Program Glossary**



- > HUD US Department of Housing and Urban Development
- <u>e-Snaps</u> The online application portal required for all levels of CoC Program applications.
- Collaborative Application The TVCoC Application for funding includes the Project Applications, Collaborative Application questions, and Priority Listing.
- Collaborative Application The CoC designated entity that is responsible for facilitating the local CoC Program Competition and completing all steps of the CoC Program Competition from January through the CoC Program funding opportunity due date.
- Project Applications Agency application for funding
- Priority Listing The ranked list of projects created by the Rank and Review Committee
- CoC Program Funding A competitive funding stream that supports programming for CoC programs such as Permanent Supportive Housing (PSH and Rapid Rehousing), HMIS, Supportive Services Only, Transitional Housing, and Joint Transitional Housing and Permanent Housing – Rapid Rehousing

## **HUD CoC Program Glossary**



- > <u>NOFO</u> Notice of Funding Opportunity, the document that details all the grant eligibility criteria, requirements, due dates, etc.
- Local Competition Notice Document provided via listserv to all CoC Members detailing a high-level overview of the NOFO
- <u>Local Competition</u> The competitive competition at the local level (TVCoC) where agencies submit their applications, and they are ranked and reviewed for inclusion in the Priority List and Collaborative Application
- Local CoC Program Timeline The timeline created for TVCoC detailing important dates in the local competition
- Bonus Funding Funding available to a CoC outside their Annual Renewal Demand. This funding is awarded based on the score of the Collaborative Application and is a national competition

When we talk about the CoC Program Application, that is funding coming down from HUD and it is funding that is specifically poured into our CoC through funding opportunities through specific programming that they fund. The CoC Program Application is officially live, which means they have released the application. The application period has opened, and the due date is October 30<sup>th</sup> of this year. I am going to go through briefly what this timeline and component of this process might look like.

In the coming weeks, you will see us send out a notice which is going to have the official notice for the funding opportunity. It is going to have information about what types of programming is available, eligibility, and criteria. It will have the amount of funding available for our CoC through what we call bonus funding.

It is my job to read through the NOFO and be able to answer questions should you have any. If I do not know the answers, I will point you in the right direction of who to ask those questions to. Always feel free to reach out to me.

You have to be able to show us your interest by a certain date. A written request can be as formal or as informal as you would like it to be. It can be a simple email saying that you are looking to go after the funding opportunity. Agency Applications will then be due in E-Snaps (the electronic portal through HUD). The Rank and Review Committee will convene and review the individual agency applications and create that priority list. If your application is not selected to be included in the overall collaborative application, then you will be notified in writing from the Rank and Review Committee.

The collaborative application is competitive across the entire nation of the CoCs. The collaborative application will be posted online. If you want to read it, please do so. You can get an understanding of what we are doing as a CoC as well to address what HUD is really focused on. You will also get an idea of what goes into the application process.

- Agency applications due in e-snaps
- The Rank and Review Committee will convene and review individual agency applications to create a priority list of all accepted applications
- Any applications not selected to be included in the Collaborative Application package will be notified in writing
- A draft of the CoC Collaborative Application will be publicly posted on the TVCH webpage for CoC review. All CoC members will be notified when it is posted.
- Collaborative Applicant will submit the Collaborative Application

This application is now open. Below are some things to look for regarding the application itself.

If you are planning on applying for funding, and you want to read through some of the documents, I really encourage you to make sure it says FY2024 on the website. This year it is going to be a two year cycle versus a one year for the collaborative application.

### Andy O'Quinn | TORCH

Am I understanding correctly that there are two different—HUD money and/or TVCOC money that you can apply for?

### Katelyn McGuire – Lead Agency

No, the way the funding is set up—and this is where it gets so complicated—When the money is awarded, it is awarded to the CoC and the agencies within the CoC. The way the funding is set up, there is a Tier One and a Tier Two funding. Tier One is the funding that is based off of your current programming. So, the programming that is already going on through this funding source they call it an annual renewal demand. They say 90% of that funding is going to be in tier one, and that is kind of as guaranteed as you can get from HUD to get the funding for that 90% of what is currently going on. The other 10% and bonus funding is what comes out of Tier Two. Tier Two is where the collaborative application score comes in. So after Tier One, they say everyone gets kind of this base funding, and we are going to go through the whole nation and

award that, and then for Tier Two, they start at the highest scoring application, and they start handing out the funding for bonus funding.

### Individual Agency News/Updates/Agency Successes:

### Andy O'Quinn | TORCH

Not on the positive news, but on the negative side. The Anderson County Public Housing received a grant to rehab all of their units. As a result, they are freezing the waiting list so that they can rehab all of their units. For an extended period of time, they are not going to have anybody shifted into income-based housing in specifically Oak Ridge.

### Kaitlyn Booth | A Place To Stay

We have received contracted documents for permanent supportive housing, and it should be up and running soon in Blount County. 8-11 units.

### Katelyn McGuire | TVCH

We have had our shower trailer out a few times. If you are interested in scheduling the shower trailer, reach out to Macrea Love, our director of outreach at <a href="mailto:mlove@tvceh.org">mlove@tvceh.org</a>. I know we are pretty booked, but we might be starting to book partnerships for next year.

### **Matt Magrans-Tillery | Cherokee Health Systems**

We have both of our Mobile Clinics. We have one mobilized. We are waiting on all the bureaucratic red tape, which is taking forever. We had to station our original mobile clinic because she is on a very large chassis. The other one is a 15-passenger van with a much smaller chassis. So now we will be able to go into our rural streets and back roads that we couldn't access before. I am hoping by the next meeting I'll have an announcement that we are starting. This is going to be medical and behavioral health care access, including some case management and possible access into medication, assisted treatment for that, for folks who have substance use disorders. Also, some infectious disease control like HIV testing and some control there with some of the prep tests. We are also looking at things like syphilis and Hep C treatment. If you can think of locations or want to partner with us directly with the Mobile Clinic, email me at Matt.Magrans-Tillery@cherokeehealth.com. Cherokee Health Systems Service Area: Hamblen, Cocke, Sevier, Blount, Claiborne, Grainger, Knox, Loudon, Union, Anderson, Hamilton, and McMinn.

The second piece of big news is that we are going to a larger location in Loudon County and we are going to have a full time pediatrician there. She is bilingual in Spanish and English. Her name is Hannah Smith.

Other big news is we just opened our pharmacy in Morristown. It is at our 5<sup>th</sup> Street office location. You do not have to be a Cherokee patient to utilize the pharmacy. If you have folks who are in the area, needing a pharmacy, and needing some pharmaceutical needs at a reduced cost, please send them our way. They can send their prescriptions there just like CVS or Walgreens.

### Katelyn McGuire | TVCH

Is there any residency requirement for the Loudon County clinic or Morristown Pharmacy?

### **Matt Magrans-Tillery | Cherokee Health Systems**

Absolutely none for either. They do need to be a Tennessee State Resident. If they are not a resident of the State of Tennessee, then we cannot utilize some of the programming that we normally use, but they still can come and see us at the reduced cost. We are never going to send anyone to collections if they are unable to pay.

### **Tonya Polidoro | MATS**

I am working with Misty Holbert here in Morristown to get their mobile clinic. Same thing you were talking about. The mental health, the regular health, all that here on MATS property. Hopefully this month. Also, Macrea is coming with the Shower Trailer this month.


### Allie Cohn Sheher | Hellbender Harm Reduction

### **CoC Data Reports and Updates**


### Nikki Lynn | TVCH

You can see, below, we had 179 Coordinated Entries Completed in the month of July. That is on par with early covid. It is hard to look at trends with the covid information and how isolated that event was. I want to remind everyone that we have not hit the hottest month of the year. Typically, August is the hottest. I would suspect that as temperatures increase, we may see an increase in ask for assistance through coordinated entry.



The next graph is our participants by county. This is the number of clients that we are serving by county. Anderson is high, Hamblin is gigh and that is because of their coordinated entry, street outreach. Good news is wed are starting to see increased numbers in other counties. Shout out to Macrea and Riley with TVCH in trying to get into counties where we do not see a lot of services.

Every month our data is only as good as the data put in. The more agencies we have that get involved in our HMIS System and data sharing, the better our report would be to show the need in our region. The Collaborative Application that Katelyn was talking about that we are submitting together to HUD to review, that is based a lot on our numbers that we are producing together as a CoC. So the more agencies we can get participating in HMIS, the better picture we can have on the needs of our neighbors in our community.





Our % of veterans and chronically homeless has increased from last month. The number of disabled individuals has decreased.

# Total number of unduplicated individuals that are actively enrolled: 297


Percentage of Veterans – 6.06%

We are gearing up for PIT & HIC. Below are some of the time commitments and responsibilities that we are looking at for our committee members.

## PIT & HIC Committee



The purpose of the 2025 Point-in-Time count is to produce a point-in-time estimate of people who are experiencing homelessness in the Tennessee Valley CoC's 12-county geographic area. The purpose of the 2025 Housing Inventory Chart (HIC) is to produce an accurate reflection of the CoC's capacity to house homeless and formerly homeless persons.



### This committee helps to plan this count each year.

The PIT & HIC Committee is looking for 12 or more individuals from community partners to help with the count in each of their counties to develop the methodologies and process for the 2025 PIT Count, which includes the following responsibilities:

- Recruiting & Training Volunteers
- · Develop the Day of the Count Plan
- · Provide Volunteer & Count support on the day of the Count
- Turning in their County's Unsheltered Count Summary & Survey Forms

#### Time Commitment - 20 - 25 hours (over the next 6 months)

- 5 one-hour long Committee Planning Meetings
- 1 Train-the-Trainer Training Session
- · Time commitment will increase leading up to the count
- Approximately 8 hours for the night-day of the count

# Rank & Review Committee



- Project applications submitted to the CoC for the FY 2024 application cycle must be reviewed and accepted/ranked, approved, or rejected by the CoC.
- The Rank & Review Committee is looking for 3-5 individuals from community partners to help with the rank and review process for 2024 NOFO, which includes the following responsibilities:
  - Help develop and update TVCoC ranking tools
  - Participate in the review and ranking process
  - Help document scores during the ranking process
  - Submit ranking outcomes to TVCoC membership
- Time Commitment
  - Up to 1 hour/ week leading up to NOFO announcement (typically early to mid-July)
  - 4-6 hours (broken into 2 days) to rank projects as a committee
  - Time commitment will increase during the review week to accommodate the review of all project applications. This can vary depending on each committee member.
