Call to Order: Katelyn McGuire – Lead Agency

Called the meeting to order 10:03 a.m.

Welcome: Katelyn McGuire – Lead Agency

We are going to go through a few things related to the Supreme Court Decision and funding opportunity for the CoC program funding.

Supreme Court's Ruling in the City of Grants Pass, Oregon v. Johnson

Case: Is it cruel and unusual punishment for cities to fine, ticket, and arrest individuals sleeping outside even if there are no shelter options available?

Timeline: The Supreme Court heard oral arguments in April and released the ruling in late June.

Decision: "Under the ruling, localities will be able to arrest, ticket, and fine people for sleeping outdoors on public property, even if leaders have failed to produce enough affordable housing or shelter for everyone in the community who needs it. "

- National Alliance to End Homelessness

Impact: Decreased trust in nonprofit agencies/ministries, possible decreased funding, increased burden on the criminal justice system, increased time to housing for folks who will now have a criminal background, which can keep them from housing and jobs

Next Steps: Advocate for sustainable solutions within communities, including—but not limited to—rental assistance programs, homelessness prevention, housing production accessible to those with the lowest incomes, and an increase in homeless assistance programs.

She is doing great taking care of her health, staying sober, she is on her meds and just a delight to be around.

MATS is almost fully staffed. We also got a \$5,000 foundation check








#'s for the Emgergency Shelter comes from Torch, Agape, and MATS. All of these #s come from HMIS.

- *The Collaborative Application is made available by HUD in the summer/fall.
- *This application process provides funding for specific programming within the CoC.
- *Any CoC Member Agency can apply for this competitive funding.
- *HUD will release information on eligibility, application focus, and other considerations with the FY24 NOFO

Whenever this application comes out, the process will start as far as there will be a local call for applications. Individual agencies will submit what are called project applications. Those will go through our rank and review committee to be reviewed. They will be scored, and they will be ranked in accordance of most likely to be funded.

If you are a CoC member agency, which means you pay your dues and you are in good standing, which means you are attending our meetings regularly, I believe it is 70%. You can apply for competitive funding. I do want to note that this funding is competitive, so the funding is competitive within our region.

Rank & Review Committee

We are still looking for folks to help with the Rank & Review Committee. Especially the actual rank and review process of things. The reading of the applications, the ranking of the applications, and scoring typically, from my understanding was like a full day last year. If you are part of an organization that is applying for funding whether you are a staff member, volunteer or board member, you are not eligible to help with rank and review. We want to make sure we keep that extremely objective when it comes to the actual ranking. BUT-you can help with tools development.

Rank & Review Committee



- Project applications submitted to the CoC for the FY 2024 application cycle must be reviewed and accepted/ranked, approved, or rejected by the CoC.
- The Rank & Review Committee is looking for 3-5 individuals from community partners to help with the rank and review process for 2024 NOFO, which includes the following responsibilities:
 - Help develop and update TVCoC ranking tools
 - Participate in the review and ranking process
 - Help document scores during the ranking process
 - Submit ranking outcomes to TVCoC membership
- > Time Commitment
 - Up to 1 hour/ week leading up to NOFO announcement (typically early to mid-July)
 - 4-6 hours (broken into 2 days) to rank projects as a committee
 - Time commitment will increase during the review week to accommodate the review of all project applications. This can vary depending on each committee member

PIT & HIC Committee

Nikki Lynn | TVCH

We are starting the Point In Time Count and Housing Inventory Chart official CoC Committee next month. We need everyone's voices in order to make it as comprehensive and inclusive as we possibly can for our region. We are looking for at least 12 individuals, one from each county that will be willing to step up and lead the point in time county for their county. But, we are happy to take anyone that wants to be involved. The goal for each of our individuals that are leading a county is to have them recruit and train volunteers to help develop a day of the count plan, provide volunteers and count support on the day of the count, and to turn in their unsheltered information.

The time commitment is 20 to 25 hours over the next six months. We are looking at about 5 one hour long committee planning meetings over the next six months and at least one training session. Eight hours for the night and day of the count.

We really need to get representations from Campbell, Claiborne, Cocke, Jefferson and Grainger.

PIT & HIC Committee



The purpose of the 2025 Point-in-Time count is to produce a point-in-time estimate of people who are experiencing homelessness in the Tennessee Valley CoC's 12-county geographic area. The purpose of the 2025 Housing Inventory Chart (HIC) is to produce an accurate reflection of the CoC's capacity to house homeless and formerly homeless persons.



This committee helps to plan this count each year.

The PIT & HIC Committee is looking for 12 or more individuals from community partners to help with the count in each of their counties to develop the methodologies and process for the 2025 PIT Count, which includes the following responsibilities:

- Recruiting & Training Volunteers
- Develop the Day of the Count Plan
- Provide Volunteer & Count support on the day of the Count
- Turning in their County's Unsheltered Count Summary & Survey Forms

<u>Time Commitment</u> – 20 – 25 hours (over the next 6 months)

- 5 one-hour long Committee Planning Meetings
- 1 Train-the-Trainer Training Session
- · Time commitment will increase leading up to the count
- · Approximately 8 hours for the night-day of the count
