Cherokee Health Systems has been around for almost 40 years. We started as a mental health clinic in Grainger County.

The mission of Cherokee Health Systems is to enhance the health and well being of our community by providing high quality, integrated, comprehensive, equitable, and person centered healthcare for all.

Cherokee Health Systems are in McMinn County, Blount County, Anderson County, Knox County, Loudon County, Claiborne County, Grainer County, Sevier County, Union County, and Cocke County. We have 20 brick and mortar sites. We have two mobile clinics. One is going to be dedicated to the Knox area just because we have a very large homeless population and people that are unable to travel. Our mobile van will concentrate on our more rural communities.

We work on making sure that we have the ability to see the patient regardless of what their need is, regardless of how they are able to pay. We do work on a sliding fee scale. Not only do we have our patient assistance program, but we have medication assistance which can include durable medical equipment. We do Adult Weight Screenings, Breast Cancer Screenings, Cervical Cancer Screenings, Childhood Immunizations, Colorectal Cancer Screenings, Dental Sealants, Depression Remission at 12 Months, Diabetes, Early Entry into Prenatal Care, HIV Screenings, Ischemic Vascular Disease,.....

Transportation, readiness for change, and being able to pay for medication.

One of the things we are really focusing on with our mobile clinic is being able to provide immediate treatment for individuals who are in active addiction and is looking for a way to move forward.

Individual Agency News/Updates/Agency Successes:

Tiffany Higgenbotham | US Dept of Veteran Affairs

We are having a Veteran Landlord Symposium on September 9. It is going to be in Knoxville at the Public Works Service Center at 3131 Morris Avenue. We are looking to engage landlords for Knox and Anderson County, possibly even Blount County that would be willing to rent to veterans who have a HUD Vash Voucher. HUD Vash is a partnership between the VA and HUD. They receive a housing choice voucher, and they receive case management from the VA. This is meant for veterans who are experiencing homelessness or are at imminent risk of homelessness. The symposium is not only going to be information about our programs, but there will be speaker from THDA to talk about funding opportunities, someone to talk about landlord and tenant law, someone talking about codes, other speakers, and lunch will be provided. This is from 10:00-2:30. This will be co-presented by Volunteers of America. We are seeking to engage landlords for the Supportive Services for Veteran Families grant as well, which is in all of the TVCEH counties.

We held a golf tournament for a fundraiser, and it went really well. It was our first annual golf tournament. We will do it again next year if anyone golfs.

Macrea brought the shower trailer to MATS. I believe he had 9-11 showers that day.

We are going to try to reach out to different partners to see if we can get additional resources while we are setting up the shower trailer if the place we are being hosted has the space and is ok with it. We are looking at different partnerships with maybe health departments, health care centers, things like that to try and get folks more of a one stop shop.

Sascha Henderson | Creating Homes Initiative/McNabb Center

Funding opportunities came out a couple of weeks ago. Those are the Creating Homes Initiative grants. There are three different ones.

The Creating Affordable Housing is aimed towards folks that have mental health needs and/or co-occurring issues.

CHI2 is more of a focus on substance use, so to create new housing opportunities for folks that have substance use issues. Primarily opioid us diagnosis.

CHI3 is focused on the reentry population.

The big difference about those grant opportunities this year, it is not like a six week cycle in which they release the announcement of funding individuals or organizations that want to submit proposals for these grants. They actually have until March 31 of next year to submit those. It is kind of a rolling application cycle.

We had some programs that are starting up here soon with A Place To Stay. Some housing coming in from McNabb Center in Blount County for reentry.

Shannon Dow |LCSW-McNabb Center

I can give an update on our transition campus. Our latest project here in Blount County, in the Blount County Transition Campus, which will create six different buildings on a campus like setting for persons entering the community from incarceration. There will be different levels of care on this campus to include a residential facility for those that are experiencing severe and persistent mental illness.

There will be a coed facility of 18 beds.

There will be a substance use treatment facility for persons who need more intensive services. Residential stay for male only facility 16 beds.

We will have four recovery homes that will have 28 beds across the four homes.

We hopefully will be breaking ground in the next few months and will have that in operation by next year.


I wanted to mention the benefits of being in our CoC. We get together in one space, once a month. We have this space where agencies can share their successes, their updates. At the end of the meetings, we can have more discussions. Some folks might be having issues, and other folks can tell them their solutions. I really find that our CoC meetings are a great place to network and learn about the resources in our region. In October, we will be having our inperson meeting. I encourage you all, if you can make it, to come to the United Way of Greater Knoxville. You can bring material items and pass them out. We typically reserve the room for a couple of hours after the meeting in case people want to hang out and network. An example is we had a client come in to TVCH who was trying to find some funding to be able to get into a space out in Anderson County. We worked with Katie at the YWCA because this person was fleeing violence. They were able to get an apartment that week.

The below report, you will see we had 150 coordinated entries.




So you can see the below pie chart that we did have an increased number in street outreach. That is due to the work of Macrea and Riley, and the TVCH team with the shower trailer. That number is also heavily influenced by TORCH.

The total number of unduplicated individuals that are actively enrolled is 466. Is it the same as our PIT numbers from this year? No, but we are starting to see with data accuracy and with more outreach, the number is creeping closer. Ideally our PIT number and our number of people served in our HMIS should be the same at any given point in time.

- <u>e-Snaps</u> The online application portal required for all levels of CoC Program applications.
- Collaborative Application The TVCoC Application for funding includes the Project Applications, Collaborative Application questions, and Priority Listing.
- Collaborative Application The CoC designated entity that is responsible for facilitating the local CoC Program Competition and completing all steps of the CoC Program Competition from January through the CoC Program funding opportunity due date.
- Project Applications Agency application for funding
- Priority Listing The ranked list of projects created by the Rank and Review Committee
- <u>CoC Program Funding</u> A competitive funding stream that supports programming for CoC programs such as Permanent Supportive Housing (PSH and Rapid Rehousing), HMIS, Supportive Services Only, Transitional Housing, and Joint Transitional Housing and Permanent Housing – Rapid Rehousing
- NOFO Notice of Funding Opportunity, the document that details all the grant eligibility criteria, requirements, due dates, etc.
- Local Competition Notice Document provided via listserv to all CoC Members detailing a high-level overview of the NOFO
- Local Competition The competitive competition at the local level (TVCoC) where agencies submit their applications, and they are ranked and reviewed for inclusion in the Priority List and Collaborative Application
- Local CoC Program Timeline The timeline created for TVCoC detailing important dates in the local competition
- <u>Bonus Funding</u> Funding available to a CoC outside their Annual Renewal Demand. This funding is awarded based on the score of the Collaborative Application and is a national competition
