

Updates in Homelessness



Ending Crime and Disorder on America's Streets Executive Order

- The Administration has expressed concern over "vagrancy, disorderly behavior, sudden confrontations, and violent attacks that have made our cities unsafe" and state that nearly two-thirds of homeless individuals report having used hard drugs like methamphetamines, cocaine, or opioids in their lifetimes and that an equally large share of homeless individuals reported suffering from mental health conditions.
- "Shifting homeless individuals into long-term institutional settings for humane treatment through the appropriate use of civil commitment will restore public order."
- Reversal of Federal or State judicial precedents and the termination of consent decrees that impede the United States' policy of encouraging civil commitment of individuals with mental illness who pose risks to themselves or the public or are living on the streets and cannot care for themselves in appropriate facilities for appropriate periods of time

Updates in Homelessness



Ending Crime and Disorder on America's Streets Executive Order

- Provide resources for law enforcement with limited resources
- HUD shall assess directional grant programs to determine whether priorities include prohibitions on open illicit drug use, urban camping and squatting, enforcement standards that address individuals who are a danger to themselves or others and suffer from serious mental illness or substance use disorder, or who are living on the streets and cannot care for themselves, through assisted outpatient treatment or by moving them into treatment centers, and implementation and compliance with the registration and notification obligations of the Sex Offender Registration and Notification Act
- Discretionary grants issued by the Substance Abuse and Mental Health Services Administration for substance use disorder prevention, treatment, and recovery will fund evidence-based programs and not fund "harm reduction" or "safe consumption" efforts

Updates in Homelessness



Ending Crime and Disorder on America's Streets Executive Order

- HUD will take steps to require persons who suffer from substance use disorder or serious mental illness participating in housing programs to receive substance abuse treatment or mental health services as a condition of participation
- Allow or require recipients of Federal funding for homelessness assistance to collect health-related information that HUD identifies as necessary
- Require those funding recipients to share such data with law enforcement authorities in circumstances permitted by law and to use the collected health data to provide appropriate medical care to individuals with mental health diagnoses or to connect individuals to public health resources

Lived Expertise Compensation Policy



Purpose

TVCH hired a part-time CoC position to focus on youth homelessness within our region. This position will focus on:

- Youth/ School PIT
- •Identifying youth/young adult needs throughout the region (12 counties)
- •Building capacity regarding a Young Adult Action Board that will help guide the CoC's understanding and strategy for youth and young adult homelessness
- •Identification of future funding streams that could bring resources to our region

THDA Project-Based Vouchers



The Project-Based Voucher (PBV) Program is a rental assistance program that links federal subsidies to qualified housing units on behalf of eligible families.

The PBV program is designed to increase affordable housing access by partnering with property owners with available rental units for eligible low-income families, seniors, and individuals with disabilities.

The PBV is tied to the housing unit within the approved property and is made available to the eligible family.

PBV vouchers are only available in the 72 counties within the THDA's Housing Choice Voucher Program service area.






